Treasurer's Report

Worshipful Work Proposal

Rev. Christina discussed her proposal re: Cultivating Worshipful Work, Spiritual Companionship, and Continuous Learning for Future Ministry. Each of the three parts were clarified by Rev. Christina as well as the Shared Elements and Wider Impact. Rev. Christina will draw from resources, make detailed plans, incorporate initial feedback and define how various committees can support these concurrent projects thus ensuring a robust launch in January, 2026. **MOTION:** Moved by Steven Britton and seconded by Lynn McClary that we proceed with Rev. Christina's proposal. CARRIED Rev. Christina would like to consider applying for a United Church grant to help with expenses related to this proposal, e.g. communication costs. The deadline date for the application is October 12; Rev. Christina has volunteered to write it up. It is also possible that there may be some financial help from the United Church's Seeds of Hope program.

Governance Review

Chair Brown shared a copy of Siloam's Governance Manual, circa 2002. She has asked that each committee review the ideas and duties that were set forth for them and update the information as it applies to the committee in 2025. Obviously, material will have to be added, deleted, merged with other committees, etc. Hopefully we can have a new revised Governance Model by the Annual Meeting in 2026. Rev. Christina volunteered to reach out to other churches and ask if they would be willing to share their Governance Models.

Staff/Committee Reports:

MOTION: Moved by Pauline Newton and seconded by Jim Anderson that the funds in the Beckstead/Newton/Johnson/McCurdy Fund be added to the Choir Scholarship Fund--both funds being Designated Funds in the Memorial and Celebration of Life Account administered by Siloam Trustees. CARRIED Dave Peeling will be providing Trustee reports on a quarterly basis to Church Council.

Steven Britton indicated that he will be attending the Fall Regional Council Meeting on October 3/4 via ZOOM.

Margaret Smith outlined upcoming services: Communion Sunday--October 5; Thanksgiving Sunday--October 12; 168th Anniversary Sunday--October 19. Margaret indicated that copies of the new published UC hymn books have been ordered for the choir members only. She expressed many thanks to Heather Vosper who has been decorating the church so beautifully.
